Beyond Multi-Tasking

C ommunication technology in today's world is reaching extreme proportions at every level of society. This "engagement" may include: talking, texting, surfing the web, looking at pictures, watching movies, shopping, sending pictures, conducting business and many other activities requiring the undivided attention of the user. Multitasking is a proficiency almost required now for daily life. People are becoming more accustomed to their multi-tasking lifestyles, despite the risks.

Possibly the greatest risk from these type of technologies is cell phone distraction causing vehicle accidents. On July 5, the NYS Legislature passed a more aggressive bill on distracted driving, which allows law enforcement to ticket



distracted drivers as a primary offense. This bill passed by the legislature will certainly improve the current status for enforcement and move the state towards reducing the number of crashes each year.

What can we do at Liberty to reduce risk to ourselves and those we support? Here are a few positive steps towards improving safety:

- Recognize agency policy which prohibits the use of cell phones while driving and be a model for safety leadership at work. We must demonstrate the behaviors expected, so put down the phone and remind co-workers to do the same.
- Find safe locations on your work routes which are good places to make calls when necessary. Pull over and save a life!

- Drivers who are speeding and attempting to use their cell phones are particularly at risk, so watch your speed and drive safely!
- Educate yourself and others to these facts:
 - Reaction time for drivers talking on cell phones is delayed as much as it is for a driver who is legally drunk.
- Drivers who are texting take their eyes off the road 400% more than when they are not texting.



• More texting leads to more crashes. With each additional text message, fatalities from distracted driving rose more than 75%.
