
Hearts Set on Achieving Success!

iberty's Board of Directors President Letah Graff announced that Michael Decker has been selected as chief executive officer to replace the retiring Frank

Capone. Decker has been an

administrator at Liberty since 1989, serving as chief operating officer since 2007. He will transition to the CEO position by January, 2012, when Frank retires after 38 years as head of the agency.

Mrs. Graff said the choice was made after an "extensive five-month national search" and interviews with many well-qualified applicants.

Mike Decker's past accomplishments include developing the manufacturing operation at Liberty to the largest, most diverse, state preferred source provider in the New York State Industries for the

Disabled (NYSID) system while he was Director of Industrial Operations. Mike also spearheaded Liberty's out-of-state business development, helping to establish Choices for Community Living in Delaware.

In looking ahead to his new position, Mike said, "I'm very excited and proud to be named as Liberty's next CEO. I'm fortunate to be part of Liberty's rich and successful history and to work with a very committed Board, dedicated coworkers and to have Frank's support and guidance as be prepares for his retirement over the next year."

Mike is a graduate of Union Graduate College, and received a Master's in Business Administration in Healthcare Management, a Bachelor's degree from the State University of New York at Plattsburg in Business Administration, and an Associates degree from Fulton-Montgomery Community College.

"The Board of Directors made an excellent choice in appointing Mike Decker as my successor," said Frank Capone. "I have every confidence that the individuals in program, their families and staff will find Mike to be a dynamic, committed leader who is dedicated to Liberty's mission and to our community." •

Liberty Board Members Honored

Two long-time board members were honored recently at a meeting of Liberty's governing board. Bob Fetterly was appointed to emeritus status and Frances "Fran" Gargiulo was appointed to emerita status in recognition of their more than 40 years of combined service. In looking back at her service on the board that began in 1984, Mrs. Gargiulo said, "Liberty has always and will always have a special place in my heart. I humbly accept this new role as Director Emerita."

Mr. Fetterly commented on his board tenure that began in 1990 by stating simply, "It has always been my honor to serve on Liberty's Board." He served as president of the board in two separate terms: from 1994 to 1996 and again from 2000 to 2002. He served at the state level on the NYSARC Board of Governors from 2001 to 2010. "Bob Fetterly is a leader and a visionary," said Frank Capone, Liberty's CEO. "He gives freely of his time and is always looking for what is best for our agency."

Capone Receives National Honor, Decker Honored by an Alma Mater

Liberty's Chief Executive Officer Frank Capone was honored by a national organization September 13. He

was inducted into the American Network of Community Options and Resources (ANCOR) inaugural Legacy Leaders Circle along with 25 others from around the country. The award was part of the 2010 ANCOR Governmental Activities Seminar conducted in Washington, D.C.

According to the web site, "The ANCOR Foundation's mission is to build the commitment and capacity of providers and communities to improve

the quality of life for people with disabilities." The award ceremony was in concert with ANCOR's 40th anniversary, and celebrated "the accomplishments of the men and women who have paved the way in making ANCOR the premier trade association representing more than 800 private providers for nearly 500,000 Americans with disabilities."

Liberty's Chief Executive Officer-Elect Michael Decker, FM Class of '81, was named a Fulton-Montgomery Community College Distinguished Alumni and received the Excellence in Not-For-Profit Management Award at a ceremony on November 19.

FM cited that, with Mike Decker's assistance, Liberty has been named one of only 200 agencies in the world to be accredited by the Council on Quality and Leadership. He is Board Treasurer/

Personal Financial Planning: KRAFT...with a "K"

William Pfeiffer, JD, from the law firm of Girvan & Ferlazzo, LLC, was guest speaker at the Liberty Fall dinner in November. He presented an important overview of personal financial planning. Here is a summation of his unique presentation.

"KRAFT" represents the wise crafting and strategies to assist you in keeping up-to-date with your estate and financial plan. You may employ strategies available under current tax law plus utilize special tools to benefit you, your loved ones, and charities you favor. Let's look at the essentials of what I call "KRAFT" and what it means:

K—Know your objectives. What are the most important family and personal planning objectives in your life and in future years, when you are gone. Focus and list them for discussion with advisors. Consideration today may avoid family conflicts, protect assets, provide for family members who will receive assets, determine when beneficiaries are to receive assets, and whether asset distribution should be outright or in trust, focus a plan for liquidity/cash to meet expenses, protect assets from creditors, keeping assets "in the family" and reduce income and estate taxes. An estate plan should also identify your personal values including the importance of giving back to the community and creating a permanent legacy through your financial resources.

R—Record your plan. Having identified your assets and objectives, and considerations for family, begin discussions with your legal advisor to record your plan. A qualified estate and probate attorney will prepare the appropriate documents to finalize your plan. These may include: wills, revocable and irrevocable trusts, powers of attorney and health care proxies.

A—Advisors who work as your team. There are professional advisors who assist you to finalize your objectives. The estate attorney is considered the team "captain" who brings all aspects of your plan together and to place it in final written form. Accountants and financial planners help evaluate assets and liabilities which must be considered in determining a true value to your net worth. Some may suggest how assets may be held (ownership/title) to minimize any possible state and federal taxation or undue expense in the transfer of assets.

A quality life underwriter can help determine liquidity requirements for payment of estate costs or other expense and liabilities, and help plan funding of important trusts. A trust officer may serve to discuss any issues of trust administration and investment management.

F-Fund your plan.

For your plan to properly evolve and function, it is vitally important to plan your assets and life insurance to fund any trust arrangement. Charitable plans must be keenly focused upon and funded at an appropriate time to

benefit family and special organizations such as Liberty Foundation.

T—Tell your beneficiaries, including charities. Your planning is critical to your family, and you should share your objectives with them, helping them to understand how you have planned, and what personal values it reflects. Share your personal concerns and that your estate plan is a manifestation of love, caring for family, friends, and charities you favor.

Communication of all aspects of **"KRAFT"** is the over-arching theme. Your plan will benefit you, your loved ones, friends, and favorite charities—including Liberty Foundation, Inc. Please feel free to contact me at 518.462.0300 with your questions. ◆

Recognizing Good Workers and Outstanding Employees

The effort to educate the American public about issues related to disabilities and employment began more than sixty years ago. In 1988, Congress took an important step by designating October as National Disability Employment Awareness Month (NDEAM).

Each year, employers and organizations such as Liberty use this annual observance as an opportunity to celebrate the contributions of workers with disabilities. Even more importantly, it provides a chance to develop partnerships with businesses and individuals to help to meet the ongoing challenge of expanding employment opportunities, and ultimately greater independence for people with disabilities.

In October, the Career and Employment Network (CEN), the supported employment program of Liberty Enterprises, marks this national observance by hosting an annual luncheon. As part of the program an Employer of the Year is selected from the many businesses in Montgomery County which partner with CEN to provide employment opportunities.

This year, Hannaford Brothers, a valuable and supportive partner to CEN for nearly 15 years, was recognized. Nearly 20 individuals have been employed at Hannaford since the relationship began. They have had an opportunity to learn job skills, earn a good wage, and become a part of the community through their interaction with customers and staff. Hannaford also earned recognition in 1997.
