**New Liberty Board Members**

AMSTERDAM- Liberty, members of the Montgomery County Chapter of NYSARC, recently elected three new members to its Board of Directors.

Michael Cinquanti, Nancy Collins and Charles Schwartz will each serve a two-year term through May 2013. Cinquanti and Schwartz both served as advisors to Liberty Board Committees and Collins serves as President of the New Dimensions in Health Care Board. The board's newest members were sworn in during Liberty's Annual Meeting on May 5.

Michael Cinquanti is a native of Amsterdam and has his Bachelor's Degree in Political Science from the State University of New York at Albany. In 1984 Cinquanti founded Genium Group, Inc. a publishing company based in Amsterdam.

In looking forward to the next two years, Cinquanti said, "My goal will be to use the expertise and knowledge I have accumulated as a businessperson to help optimize services for the Individuals Liberty supports."

Nancy Collins has been a member of the New Dimensions in Health Care Board of Directors since 1999 and President of the Board since 2009. Collins also serves as Councilwoman for the Town of Mohawk and is a member of the New York Group Managers Association of Northeast New York.

Collins stated that she feels honored to be affiliated with such a wonderful organization as Liberty and, "would like to utilize my diverse healthcare management experience to ensure that the high quality of medical and dental services provided by New Dimensions in Health Care will remain available for individuals with disabilities."

Charles Schwartz, Esq. is also a native of Amsterdam. He received his Bachelor's Degree from the State University of New York at Albany and his Juris Doctor at Albany Law School. Schwartz serves as Town Attorney for Amsterdam and on the Counsel of Amsterdam's Industrial Development Agency.
