Liberty ARC Awarded \$24,542 in Grants from NYSARC Trust Services

To support guardianship and recreational opportunities for people with disabilities in Montgomery County

AMSTERDAM- Liberty ARC, the Montgomery County Chapter of The Arc New York, has been awarded \$24,541 in grants from the Trustee Management Board of NYSARC Trust Services to support the agency's recreation programs and guardianship program.

NYSARC Trust Services administers supplemental needs trusts (SNT) and pooled trusts that can make dramatic improvements to the lives of people with disabilities by enabling individuals to maintain eligibility for Medicaid and other means-tested government benefit programs. For 2021, NYSARC Trust Services is proud to fulfill its commitment to enhancing the lives of people with disabilities by awarding a total of \$3,080,500 to The Arc New York Chapters statewide.

This year, Liberty ARC received \$18,000 to provide new recreational opportunities and enrich the lives of the more than 550 individuals we serve. Liberty ARC has used these funds to purchase a variety of fun activities including camping trips, game nights, movie tickets, wrestling tickets, bowling, art classes, concert tickets, amusement park day trips, and theater shows. The agency also purchased art supplies and admissions to outdoor events such as minor league baseball, fairs, hayrides, and batting cages.

Liberty ARC also received \$6,542 in grant funding to provide guardianship services for people with intellectual and developmental disabilities who would not otherwise have a legal guardian or advocate. Supported by Chapter staff and community volunteers, Liberty ARC's Guardianship Program currently provides guardianship supports and services to people and support as a standby or alternate standby guardian.
